Sub: Recognition from class I to VIII without aid.

With reference to your application on the above cited subject, I am directed to convey the approval of D.E. for grant of provisional recognition to your school from class I to VIII w.e.f. 1.5.79 to 30.4.81 without aid on the following conditions:-

- That the school shall establish a well equipped Science Lab. within a period of 6 months and spend Rs.7,000/- for this purpose.
- The Books worth Rs.5,000/- shall be added in the school library within a period of 3 months. Out of this Rs.2,500/- shall be spend on the purchase of books on Science Subjects.
- The benefit of provident Fund will be extened to the teachers and other staff who are entitled according to the provisions of Delhi Education, 1973.
- Adequate land for the school building should be arranged within a period of one year.
- A play ground should provide immediately and facilities for Physical Education should be made available for the students.
- The school should continue to pay the prescribed Govt. pay scales and all allowances to all the employees of the school and payment should be made by crossed cheque.
- Service of any employees should not be terminated without the prior permission of the Director of Education.
- The unqualified and over age staff would be replaced by qualified staff within the prescribed age limit within 3 months.
- A Reserve Fund for Rs. 5,000 would be deposited under the joint names of the Director of Education and the Manager of the school within two months.
- Health and Sanitary certificate would be produced within one month.
- The school should maintain the accounts correctly and cash book shall be written on proper lines and duly authenticated.

Sir,

With reference to your application on the subject cited above approval for the up-gradation of the existing middle school to Secondary level is granted w.e.f. 83-84 session subject to the fulfilment of terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act and Rules framed thereunder, as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall appoint full time qualified and eligible staff for all classes of the school as per the present norms of the Department.
4. That the school shall equip the school with as per the norms of the Department and suitable facilities for practical work shall be provided to the students.
5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per students may be added.
6. That adequate sports material shall be purchased and made available to the students immediately.
7. That That the school shall strictly abide by the provisions of Sec.10(1) of the Delhi School Education Act & Rules, 1973.
8. That the enrolment in section shall not exceed the number of students calculated @ 12 sq. ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in each class. Number of sections should not exceed the number of existing class rooms of proper size in the school. And number of students in each class shall be restricted upto 28 only.

9. That the school shall not run any unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery class be removed from the premises of the school, if any.
10. That the School Society will obtain the Health Certificate from the Municipal Corporation of Delhi.
11. That the scheme of management shall be got approved from the Department immediately.
12. That the service contract between the management and the employees shall be executed immediately.
13. That all the facilities prescribed under Rules 50 & 51 of the DSER, 1973 shall be made available to the students.
14. That the arrangements for good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately.
15. That the management of the school shall create a reserve fund of Rs. 10,000/- (Rs. Ten Thousand).
16. That the violation of any instructions/orders/conditions/rules and regulations of the Department shall lead to the withdrawal of recognition of the school. That class XI shall not be added to the school without the prior permission of Director of Education, Delhi.
17. That the management of the school shall procure land from D.D.A. for the school and construct the school building for the school by December, 1983 and the school is shifted to new building.
18. That the report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled, shall be sent to the Director of Education every six months.
